## **Project Specialist (Land Acquisition, Civil Engineering, Legal) (PS3) – 03 Posts**

Basic Qualifications (1 or 2 or 3 below)

1. A successfully completed Bachelor's Degree in the relevant field, which is recognized by the University Grants Commission

A qualification recognized by the University Grants Commission as an equivalent qualification to the degree in the relevant field

A professional qualification successfully completed from recognized professional institute in the relevant field

## **Terms and Conditions of Service**

An officer confirmed in the Public Service, Provincial Public Service including Local Authorities, Public Corporations, Statutory Boards and Fully Owned Government Companies has to get temporarily released from the substantive post on full time basis on no-pay leave and persons outside of the government service will be recruited on contract basis. The contract basis appointments will be initially for a period of one year and will be extended based on the successful performance.
