**Relief Mechanism to expedite the Rehabilitation and Reconstruction work in
Flood and Landslide damaged areas**

Your kind attention is drawn to para 7 and 8 of the Circular No. MNPEA 04/2017 dated 22.08.2017 issued by this ministry on the above matter.

2. In keeping with several representations received by the ministry with regard to implementation of guidelines under para 7 and 8 of the said Circular, respective paras are amended to be read as follows;

Para 7

“Procurement Committee should ensure that works will be fairly distributed among CIDA registered contractors, giving priority to contractors in the respective region also to ensure transparency, value for money and equal opportunity to participate in prospective contracts”.

Para 8

“If price quoted by the contractor is higher than the engineer’s estimate, Procurement Committee should negotiate with the respective contractor in order to obtain appropriate price reduction”.

3. The other provisions of the said Circular MNPEA 04/2017 are remain unchanged.
